

# Discount regulations

## "Mother's Day"

1. These "Mother's Day" Discount Regulations (hereinafter: "**Discount Regulations**") specifies the conditions for granting discounts on prices for postal or transport services provided by **InPost Sp. z o. o.** with its seat in Kraków at ul. Wielicka 28, 30-552 Kraków, entered into the register of entrepreneurs kept by the District Court for Kraków - Śródmieście, XI Commercial Division of the National Court Register under the number KRS 0000543759, NIP: 6793108059, REGON: 3607810850 share capital PLN 116 278 450.00 (hereinafter referred to as: "**InPost**" or "**Operator**"), as part of the "InPost Quick Send" functionality, available at the Internet address: [www.SzybkieNadania.pl](http://www.SzybkieNadania.pl), (hereinafter referred to as the "**Website**") and based on the, current for the day of sending the Shipments, "Terms and Conditions for the Provision of the "Parcel Lockers 24/7" Service by InPost Sp. z o.o." (for Shipments delivered to Parcel Lockers and PUDO points), and the "Terms and Conditions for the Provision of Postal and Shipping Services by InPost Sp. z o.o." (for Shipments delivered to an address other than the address Parcel Locker or PUDO Point / POP, marked on the Website as " Home "), hereinafter referred to as the "**Terms and Conditions**".
2. The Terms and Conditions apply to the extent not regulated in these Discount Regulations and all capitalised terms not defined in these Rebate Regulations are used in the sense given to them in the Terms and Conditions appropriate for a given postal or shipping service, depending on the place of delivery of the Shipment specified by the Sender when ordering this service through InPost Quick Send.
3. On the basis of these Discounting Rules, the Operator - for the duration of the discount specified in sec. 6 below - grants the Senders using InPost Quick Send a discount on the prices of their services available on the Website, in accordance with the provisions below.
4. The discount covers a reduction, for the duration of the promotion, in the prices of services provided through InPost Quick Send, as specified by the Terms and Conditions. The discount is granted, under the conditions set out in the Discount Regulations, all types of Shipments and Sizes available through InPost Quick Send, as presented below:

5. The discount will be applied on the Website during the discount period for each Shipment, if the Sender carries out the following steps in sequence when entering the order on the Website:
  - 1) choose the Size
  - 2) in the right part of the Website the Website, in the "Summary" field, select the check-box "I have a discount code",
  - 3) in the field designated for entering a discount code, provide the following code: DLAMAMY
6. The correct weight of the Shipment will be verified by the Operator as specified in the Terms and Conditions.
7. The discount period starts on May 21, 2021 and ends on May 24, 2021. The operator reserves the right to extend or shorten the discount period by changing the Discount Regulations.
8. These Discount Regulations come into effect on May 21, 2021 The Operator will inform the Senders about changes to the Discount Regulations in advance, in the form of information posted on the the Website.
