Fuel Fee

InPost International



Fuel fee is a surcharge applied in international transport, which is added to the basic price of each parcel.

InPost International Fuel fee rate from July 15 to July 31, 2025: 0,00%

The fee is calculated on the basis of the wholesale prices of Ekodiesel (price in PLN per 1000 l [m³]) published by Polski Koncern Naftowy Orlen S.A.

The InPost International Fuel Fee is based on data provided by Polski Koncern Naftowy S.A. on its website at www.orken.pl.

The InPost International Fuel fee is calculated based on the average* wholesale market price of Ekodiesel from the previous settlement period. The fee is rounded to the nearest whole PLN 1,00.

* the average wholesale market price is rounded to the nearest whole zloty by rounding down any amounts of less than PLN 0,50 and rounding up any amounts of PLN 0,50 or more.
