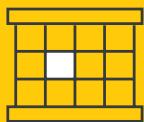

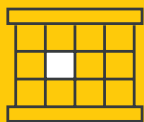

# Dictionary: Primary Services



<b>InPost Parcel Lockers 24/7</b> (InPost Paczkomaty 24/7)	InPost Paczkomaty 24/7 is a service that offers collecting, shipping, and dispatching shipments by means of a user-friendly automatic parcel machine - InPost® Paczkomat.
<b>Fast Returns</b> (Szybkie Zwroty)	The Fast Returns service makes it possible to return goods purchased in an online store, which has a Business Contract with InPost easily and quickly. The return process is fully labelless with the use of 10 number digital code and can be dispatched at any of InPost's Automatic Parcel Machines.
<b>Pass Thru</b> (Podaj Dalej)	The Pass Thru service makes it possible to dispatch, and to collect a shipment at the same Automatic Parcel Station of InPost. The recipient of a shipment may collect it immediately after placing the shipment in an Automatic Parcel Station. The „Podaj Dalej” service is available only for the Customers who have concluded a Business Contract, excluding any shipments being dispatched within the Allegro Paczkomaty 24/7 InPost service.
<b>Parcel Manager</b> (Manager Paczek)	A tool available at <a href="https://manager.paczkomaty.pl/">https://manager.paczkomaty.pl/</a> , dedicated to Retail Customers, which makes it possible to order services with the use of an account created there.
<b>InPost Fast Send</b> (InPost Szybkie Nadania)	A tool dedicated to Retail Customers which makes it possible to order services quickly and conveniently through the website <a href="https://inpost.pl/SzybkieNadania/">https://inpost.pl/SzybkieNadania/</a> .
<b>InPost Mobile App</b>	A tool dedicated to Retail Customers which makes it possible to order services quickly and conveniently, using InPost Mobile App, without the need to print a dispatching label.



# Dictionary: Additional Services



<b>Additional insurance</b>	A service available for insured Shipments (as defined by the Terms and Conditions) containing commercial goods or valuable items up to the gross value specified.
<b>Cash on delivery up to PLN 5 000</b>	The cash on delivery service (COD) allows to order a shipment with the option of making the payment by the Recipient, before its collection. Maximum amount collected – up to PLN 5 000.
<b>Parcel on Weekend</b> (Paczka w Weekend)	An additional service (available within the InPost Paczkomaty 24/7 service) consisting in deliveries of shipments dispatched on Friday or on Saturday, on weekends. The limit hours for dispatching, being in force within the service, are included in the Terms and Conditions of the InPost Paczkomaty 24/7 service.
<b>Pick-up service</b>	Payable courier pick-up visit at dispatching a specific number of shipments (ad-hoc). The service is included in the price, if the Sender orders 5 and more shipments at once, and the Parcel Station Shipments being sent on the basis of the current Terms and Conditions of the Paczkomaty 24/7 service sum up with the courier shipments and elements of freight shipments being sent on the basis of the current Terms and Conditions of the Postal and Carriage Services offered by InPost Sp. z o.o. The fees for the service do not apply to the subscription contracts, unless the provisions of such a Contract specify otherwise.
<b>Paper invoice</b>	An invoice printed out and recorded on paper, for services provided by InPost sp. z o.o.



# Dictionary: Additional Fees



To avoid the fees, make sure that you declared the size of your shipment correctly when creating the label, and that your shipment does not exceed the maximum weight and dimensions for the given service.

More details regarding the dimensions, the classification of parcels, and the correct ways of packaging can be found in the document **Preparation and packaging rules for InPost parcels** under the link <https://inpost.pl/en/regulations>.

<b>Shipment verification when changing the size*</b>	The fee is charged when sending a shipment, the actual size of which is inconsistent with the size declared. When creating a shipment, remember to select the right size in terms of the minimum and maximum height and width.
<b>Verification of Shipment weight and dimensions*</b>	The fee is charged in two cases: a) exceeding the maximum acceptable weight for parcel station shipments (25 kg), or b) exceeding any of the maximum dimensions for Size C for Parcel Station Shipments of 410 x 380 x 640 mm (height x width x length).
<b>Fee for treating the Shipment as oversized*</b>	The fee for verifying the weight and dimensions of a Shipment is charged together with the fee for treating the shipment as oversized.
<b>Oversized shipment – exceeding the dimensions 500 x 500 x 800 mm or a weight of more than 30 kg*</b>	The fee is charged in two cases: a) exceeding the weight of 30 kg for automatic parcel station shipments, or b) any of the dimensions 500 x 500 x 800 mm (height x width x length) is exceeded.  Caution: this fee applies together and sums up with the Fee for Verifying the weight and dimensions of a Shipment and the Fee for treating a Shipment as oversized.
<b>Return to Sender</b>	In the cases specified in the Terms and Conditions, in particular when the recipient is missing, refuses to accept the shipment, or the address is incorrect, the Operator shall return the shipment to its dispatch address. The fee for the Return to Sender is equal to the net fee paid when sending it (increased by the VAT), with the proviso that it will be equal to the net fee for the Shipment according to its actual weight and dimensions determined by the Operator (increased by the VAT), in the event of differences between weight and dimensions: actual and declared by the customer.

\* the fees do not apply to Senders being Consumers

In the case of Business Clients who have concluded business contracts with the Operator providing for a fee in arrears in the form of the so-called subscription (a fixed fee for the service agreed in advance and the readiness to render the specified amount of the services by the Operator), for the Services the prices of which are not specified in such a contract, the prices as specified in the Pricelist binding on the day of the conclusion of this contract apply, unless its provisions state otherwise.



This Pricelist is subject to the provisions of the Terms and Conditions of "Paczkomaty 24/7" Service provision by InPost Sp. z o.o. binding as at the date of dispatching the Shipment, in particular in the scope of the terms used in the Pricelist and the services being provided. This Pricelist (it is to be treated independently and without a clear association with other offers of InPost), does not constitute an offer as defined by the regulations of the Civil Code.
