InPost International - Parcel to Poland Service

InPost International – Parcel to Poland is a service enabling the Sender to dispatch a parcel at a parcel locker or PUDDO point in the following countries: Belgium, France, Netherlands, Luxembourg, Spain, Portugal, Italy, with delivery to a Paczkomat® parcel locker or a PUDDO point in Poland. Parcels under this service are handled by the following companies belonging to the InPost Group, providing courier services in the relevant country of dispatch, in accordance with separate terms and conditions available on the InPost website at: <https://inpost.pl/en/rules-and-regulations#international> (section: Retail Customer – Parcels from Abroad to Poland).

GLOSSARY

Additional fees and services

To avoid charges – make sure you correctly declare the size of the parcel when creating the label, and that your parcel does not exceed the maximum weight and dimensions and does not contain any prohibited items. More details on dimensions, classification of parcels and correct ways of packaging can be found in the document **Guidelines for the preparation and packaging of InPost International parcels** at <https://inpost.pl/en/rules-and-regulations#international>.

| Return to Sender* | In cases specified in the terms and conditions, in particular when the Parcel has been successfully delivered to the parcel locker or PUDO point but has not been collected by the Recipient within the specified time limit, the Operator shall return the Parcel to the Sender's address. The fee for returning the parcel is equal to 100% of the net fee paid at the time of dispatch (increased by the applicable VAT), provided that, in the event of any discrepancies between the actual weight and dimensions of the Parcel and those declared by the Customer, the return fee shall be equal to the net fee applicable to the Parcel based on its actual weight and dimensions as determined by the Operator (increased by the applicable VAT). |
| Oversized Parcels* | The fee is charged in two cases: a. exceeding the weight of 25 kg for Parcel, or b. exceeding any of the dimensions of 500 x 500 x 800 mm (height x width x length). |
| Improper packaging fee* | The fee shall be charged if the packaging of the Parcel does not meet the requirements set out in the terms and conditions, in particular if it does not provide adequate protection of the contents or may cause damage to the Parcel or to other parcels during transport. |
| Prohibited contents fee* | The fee shall be charged if a Parcel contains items prohibited in accordance with the terms and conditions, including goods which transport is excluded or restricted by applicable law or by the rules governing the provision of the Service. |
| Incorrect labelling fee* | The fee shall be charged if the Parcel has been labelled incorrectly, in particular if the label is illegible, damaged, incorrect or placed in such a way that prevents proper identification of the Parcel. |
| Additional cover up to PLN 5 000 | A service available for insured Parcels (as defined in the Terms and Conditions) containing commercial goods or valuable items up to the gross value specified. |
