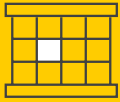

InPost International Service and Additional Services



InPost International Service

InPost International	InPost International is a parcel shipping and delivery service from Poland to pick-up points in the following countries: France, the Netherlands, Luxembourg, Belgium, Italy, Spain, and Portugal.
Additional cover	A service available for insured Parcels (as defined in the Terms and Conditions) containing commercial goods or valuable items up to the gross value specified.
Shipment to islands	A service for shipping Parcels to pick-up points located on islands that are territories of the countries covered by the InPost International service. The list of islands currently includes: Corsica, Sardinia, Sicily, Mallorca, Menorca, and Ibiza.



Glossary: Additional Fees

To avoid charges – make sure you correctly declare the size of the shipment when creating the label, and that your shipment does not exceed the maximum weight and dimensions.

More details on dimensions, classification of parcels and correct ways of packing can be found in the document **Rules for the preparation and packaging of InPost International shipments** at <https://inpost.pl/regulamin>

Parcel verification after changing the size*	A fee is charged when the Parcel's actual size does not match the size declared by the sender. When creating the shipment, remember to select the appropriate Parcel size for the minimum and maximum height and width.
Oversized Parcel handling fee*	The fee is charged in two cases: a) for exceeding the maximum permitted Parcel weight (25 kg), or b) for exceeding any of the maximum dimensions for Size C Parcels: 390 x 380 x 640 mm (height x width x length).
Oversized Parcels – larger than 500 x 500 x 800 mm or heavier than 30 kg*	The fee is charged in two cases: a) for exceeding the Parcel weight of 30 kg, or b) for exceeding any of the dimensions 500 x 500 x 800 mm (height x width x length).
Return to Sender	In cases specified in the Regulations, in particular in the absence of a recipient, refusal to accept the shipment or an incorrect address, the Operator will return the shipment to the sending address. The fee for returning the Shipment is equal to the net fee paid when it was sent (increased by VAT), with the proviso that it will be equal to the net fee for the Shipment according to its actual weight and dimensions determined by the Operator (increased by VAT), in the event of differences between the actual weight and dimensions and the ones declared by the Customer.
Contractual penalty*	The Operator may impose a contractual penalty on the Sender in the amount specified in this Price List, for violations specified in the Regulations for the provision of InPost International services for Retail Customers.

*fees do not apply to Consumers



This Price List shall be subject to the Regulations for the Provision of InPost International Services to Retail Customers applicable on the date of sending the Shipment, in particular with regard to the names and services included in the Price List. This Price List (treated independently and without an explicit connection with other InPost offers), does not constitute an offer within the meaning of the provisions of the Civil Code.
